Donna Hilliard, our new 2<sup>nd</sup> VP and Membership chair, has set a goal for 200 members. Currently we have 193 members and of those 50 are new. We have 59 associates, 14 of whom are new.

We had an update by County Commissioners, a recap of the legislative session by local legislators, and the difference between Republicans and Democrats presented by our County Chairman. We also had an update from Sheriff Ferrari on Second Amendment Sanctuary Counties, where our county stands, and why he has chosen to defend our rights as armed citizens. In May, George Sharpe of Merrion Oil and Gas, gave an informative presentation the role of fossil fuels in our energy future.

Our 3<sup>rd</sup> VP and Fundraising Chair, Neeva Meeks, is organizing a golf tournament as our bi-annual fundraiser. The event will be September 7. Team slots are quickly filling up, giving us a positive step towards our \$11,000 goal.

FCFRW worked closely with San Juan County RP on community events. We recently staffed a booth for *The American Legion Centennial Jubilee in Aztec* and will help staff and organize the July *Ice Cream Social and Rally*. By focusing on being a large presence in San Juan County, we are hoping to surpass previous membership and keep San Juan County red. Our club has applied for a Diamond Status in 2018/2019 and looks forward to an exciting rest of the year.

#### Los Alamos FRW - President Shona Neff

As 2019-2020 officers settle into their roles, we are finding successes, as well as experiencing some of the same challenges from 2018.

First the successes. After not having any fundraising in 2018, we were excited to hold our first ever *Personali-TEA*, which was met with better than

expected attendance and great feedback. According to long-term members, it was one the most successful fundraisers ever held by LAFRW. We did not have an annual yard sale last year, but are planning one for July. We hope to be more visible in our community.

We've had 50-65 attendees at monthly luncheons and speakers on similar policy topics and legislative session updates. We heard from NM Business Coalition's Carla Sonntag, NRA State Director Alexandra Garza, Bobbie Terrazas, NMSP on Human Trafficking, Anita Statman on the Border Crisis, and Anisa Golden-Morper on Optimism.

We're currently on our June – August summer break, though the board is preparing for our first 2020 election cycle fundraiser - our *Great American Picnic*. If you're looking for a one-day getaway, our picnic may fit the bill. We have live country music, dance instruction, yard games, and raffles galore, and of course a full BBQ. It's July 27 in Las Campanas from 4:30-7 p.m. We've sold 65 tickets out of 100.

The board has initiated monthly meetings with our County GOP. We decided it was time to put the women of SFFRW to work alongside the GOP. We have the manpower and they have the know-how to get out the vote. Together we have distributed precinct data to all SFFRW members attending our meetings. We are empowering our army to light a spark in their neighborhoods, to get to know 'closet Republicans,' invite them to our events, and get them more active in SFFRW and GOP efforts to re-elect President Donald Trump.

#### Lea County FRW - Carol Parish

We have 44 members with 19 associates. Our **new** club *Bylaws and Standing Orders* are complete. Now, we are working on **Membership Booklets**. They will contain our Bylaws and Standing Rules, where to obtain NM and Nat'l. Bylaws, Republican Philosophy, History of Republican Women, Difference between Republicans and Democrats, contact information for elected officials and the club, Executive Board, club committee chairs and more.

The aggressive phone and email campaign of our Lea County FRW members resulted in Lea County Commissioners passing resolutions stating that Lea County is a 2<sup>nd</sup> Amendment Sanctuary County, a Sanctuary County for the unborn, and pro-fracking.

The trip to Hobbs is 500+ miles from the NW corner to SE corner of NM. We were honored that Pres. Rhonda Stockert and 3<sup>rd</sup> VP Ginger Paternostro made the trip to swear in club officers.

County Assessor Sharla Kennedy, spoke on her "Guide to Property Assessment", explaining what needs to be evaluated/re-evaluated, due dates, property assessments and tax notices.

In March, NM Representative David Gallegos reviewed what happened at the NM Legislative Session and with the *GO Rogue* NM Sheriffs.

Senator Stuart Ingle defined what an increase in population means to NM and how redistricting will change NM's House & Senate. Senator Gay Kernan went over the *HB56 Tax Reform Bill and Increase Amendment*, resulted in a **\$26 million tax increase**.

In April, Repr. Phelps Anderson spoke about NM's budget increasing \$7 billion, going up next year. He showed us what money came into Lea County.

Our club provided personal care items to *Humphrey House*, a residential treatment center for teenagers - one of our Community Service Projects. Members send birthday cards to young people living at Humphrey House monthly. Often this is the only recognition they receive on their birthdays.

Representative Larry Scott also spoke on NM's budget and that taxes increased by 13% overall to balance the budget. The tax increase was voted in the last day of the session.

In May, Nicholas Maxwell, a Lea County technology professional spoke on cybersecurity. He told us how to protect passwords, anti-viruses, scams, and identity theft. Nick also spoke on *The Secret Ballot at Risk: Recommendations for Protecting Democracy*. Good information in simple language!

Our Americanism Chair gives us information on protocol and history monthly. We continue to help local veterans-in-need.

#### Lincoln County FRW - President Ann Eby

FRWLC mainly concentrated on our 2nd Annual Afternoon Tea & Fashion Extravaganza, which proved an even greater success than our first. With more members, we covered more businesses and involved more of the community in our program. The purposes are to promote goodwill in our business community, generate a better economy, stimulate tourism, and showcase our Republican Women.

Last year, our selected 501-c-3 was *Life-Way*, a Pregnancy Resource Center assisting in choosing life with education, resources, ultra-sound, and adoption assistance. We were able to donate \$900, plus contribute a sizeable amount to our PAC account.

# Focus on NMFRW Member Roswell Daily Record Sunday Spotlight – Inspiring Lives, by Alex Ross, May 5, 2019

Our own Joan Boué was featured in an article, which described her background, religion, politics, and abundant volunteer work. Raised in Philadelphia, she graduated with a BA in Education from Villanova Augustinian Catholic University. Joan later earned a degree in theology in the mid-1970s. She married her first husband and had a son, John, and daughter,

Lisa; moved to Massachusetts and then Albuquerque. As a stay-at-home mom, she volunteered in activities that involved her children and her church.



"For Joan Boué, politics has always been a passion." It was when she served as Central Committee member on the Bernallilo County RP and RPNM Central committees in 1978 that she met husband Hudson Boué, who was running for sheriff. They married in 1990 and moved to

Virginia, so Hudson could take a job as attorney for the U.S. Department of Interior. While there, they were "fixtures in Republican politics" and entertained famous Republican elected officials and other newsworthy conservatives. The Boués attended the Bush 41 and 43 inaugurations and were invited to the 2005 White House Christmas Party.

The Boués retired to Roswell, where Joan joined CCFRW and grew membership from 28 to 202. Joan served as Chaves County FRW President from 2014-2017. Under her leadership, the club has funded college educations for as many as 5 people through scholarships, honors veterans, and initiated the very successful Annual Cowboy Prom Fundraising event.

Her other volunteer activities include working with low income children, women, and the homeless.
