

The NM Republican Party held it's State Central Committee and Quadrennial Convention on April 27th in Albuquerque, NM.

The State Central Committee voted to postpone voting on any rules until the fall meeting.

The 2024 Quadrennial Convention was called to order by Chairman Steve Pearce with over 700 attendees present.

The guest speaker was Congressman Wesley Hunt from Texas. He gave a very inspiring talk on why is he is a Republican and rallied all of the crowd to get out the vote in November. Yvette Herrell also spoke about her campaign.

#### Members at Large (Continued)

The next item on the agenda was the election of National Committeeman and Committeewoman. Jim Townsend was elected unanimously. Current Committeewoman Tina Dzuik and Sara Jane Allen ran for the Committeewoman position. Tina was re-elected and will continue to represent NM. We also elected the Delegates and Alternates to represent NM at the Republican National Convention in Milwaukee, WI in July. They will nominate Donald Trump for President.

There were a number of NMFRW members present at the convention. I would like to encourage more of our members to become active in this process. It is exciting and you get to participate in how the process works

At the State Central Committee Kimberly Skaggs was elected as Treasurer and Congressional District 1 was the only contested primary race and both Steve Jones and Louie Sanchez received enough votes to be on the primary ballot.

## Committee Reports

#### **Americanism**

#### Campaign/Political Education

Now that the primary is over, it is time to get busy training again.

In March Dianne invited us to Los Alamos to hold a training on sidekick and GOP Data Center, and in Valencia County our first training session for Challengers was held right before the primary.

The Republican Party is pushing ""Get Out the Vote" and we have a place in it. Only 22% of voters in New Mexico voted in the primary. While I think there will be more interest (and possibly more controversy) in the General election we need to push our friends and neighbors to get out and vote. Encouraging voters to get out early assures them they have the opportunity cast their ballots for the candidates of their choice but, they may need to

be reassured their votes will count. Absentee ballots aremore of a challenge. While convenient, with the problems the postal service has, it may not be the most efficient way for the voter. Some voters don't receive ballots they requested, some forget they received them and return them too late. Others don't leave enough time for them to make it to a sorting city in another state and back to be counted.

A major concern across the county is ensuring that only US Citizens participate in federal elections. Governmental agencies including the Border Patrol are being required to register eligible voters that they come in contact with to vote. Senator Mike Lee (R-UT) and Representative Chip Roy (R-TX) have introduced the Safeguard American Voter Eligibility (SAVE) Act. With the massive influx of illegal aliens crossing our boarders coupled with the passage of laws requiring government agencies to become voter registrars and laws prohibiting registrars from asking for proof of Citizenship it becomes difficult to know if non-citizens are being registered to vote. The SAVE Act requires states to verify US Citizenship, compels states to purge non-citizens from voter rolls and establishes federal penalties for intentionally registering non-citizens while requiring states to set up alternative verification processes for citizens without standard documents. Voting is a right and a responsibility of American citizenship and it is our responsibility to protect the integrity of our electoral process.

I am in the process of working with RPNM to set up trainings beginning with Campaign Contribution Limits via ZOOM next month, then by the end of July I plan to set up another sidekick/GOP Data Base training – I have plans on a different training each month leading up to the election. Stay tuned for further information.

#### **Upcoming: Special Session of NM Legislators called for July 18**

In July, New Mexico lawmakers will be called up to Santa Fe this summer to consider bills related to criminal competency, gun charges and panhandling. State lawmakers will consider new proposals for reducing "danger and risk" in the state. Senate Majority Leader Peter Wirth (D-Santa Fe) will focus on legislation that required more legal review, "namely: criminal competency, felon in possession of a firearm and panhandling." the goal of the competency proposal is to address a shortfall in mental health treatment.

#### **Scholarship**

Each year NMFRW awards a scholarship to assist a deserving female student to further her education at a college or vocational school in New Mexico. The value of the scholarship is \$1500, with \$750 being disbursed each semester. It can be used for tuition, room, board, books, fees or other enrollment requirements.

Applicants must meet the following requirements to qualify:

- 1. Be a NM Resident
- 2. Be a registered Republican or the daughter of a registered Republican if she is under 18.
- 3. Be a member of the current year's graduating class (including home school) and accepted for enrollment in an institute of higher learning in New Mexico. OR Be already enrolled as a full-time student in an institute of higher learning in New Mexico.
- 4. Have a 3.0 or better grade point average based on a 4.0 system.
- 5. Plan to study government, political science, international relations, or history. **OR** Show significant participation in political activities (i.e. Girl's State, student government, local or state government activities, working on election campaigns, etc.)

In January, NMFRW President Teresa Barncastle sent all club presidents a letter accompanied by a scholarship application which was to be shared with any Republican senior girls they thought would be a possible candidates. The deadline for submission of applications was April 5. The committee comprised of myself, Teresa Barncastle, Joan Boue, and Terry Marzili met via Zoom on April 12. We had three applicants who met all the requirements. A fourth applicant was eliminated because she was planning to attend a college out of state. Our criteria were their area of sturdy, their political activities and other extracurricular and volunteer activities.


We are happy to announce that the winner is Dallye
