On Saturday reports were given and the meeting adjourned at lunch. Gail Armstrong was scheduled to be our speaker before lunch but was called into session and was unable to attend.



This past election year was an exciting and busy time and never before have we had so many of our members actively engaged in assisting Republican candidates on the local and state levels with their campaigns. Ladies were assisting with fundraising, writing thank you notes, calling, handing out flyers, going door to door as walkers, and engaging in lively conversations with friends and neighbors at Meet & Greets. We created a flyer titled "Know Their Votes" that listed conservative candidates running in Dona Ana County. As a result, we were able to donate \$250 to Rachel's Vineyard (a psychological and spiritual journey for healing after abortion) and \$400 to Honor Flight.

We had a goal of 85 members for 2024 and exceeded our goal by one member, bringing our total membership to 86. Associate membership doubled in 2024 to 12 members. July, August and September meetings were record setting with 90 people in attendance at





Several members attended the RPTC monthly meetings and organized the RPTC Biennial Convention on January 17th, to


elect new officers. Congratulations to Sadie F. Boyer, Sue Simmons, Nickie McCarty, Cindy Medina and Linda Rael on their election.
