Region D Director Jeanine Corn Best I am so blessed to have had the privilege of being the NMFRW President for another two years. Because of all our efforts we remain the largest women's grassroots political group in New Mexico and as a part of the NFRW in the nation.

> The NMFRW added a new club, the FRW of Sierra County, bringing our club count to 18. Additionally, we have several prospective areas considering a club. We will continue all efforts to add clubs in all jurisdictions thus strengthening our Republican ideals.

My membership records go back to 2017 and the NMFRW is the largest it has ever been within these years. We almost hit my goal of 1000 members. We are only short 16 members and I am sure we will meet that goal in the near future. We did win the Percentage Bracket in the NFRW 70K membership contest.

This will provide the NMFRW President her Regent fee valued at \$1000 that is normally paid by the NM Federation.

The NMFRW continued our winning streak at the 2025 NFRW Biennial Convention which was attended by 9 New Mexico Delegates. We were again awarded the Betty Heitman State Achievement Award of Excellence which is the highest level. Twelve of the New Mexico clubs earned a Diamond Achievement Award, the highest level, and 2 earned Silver status. Gail Tripp, Socorro County FRW won for our state for making the most calls. NM Senator Candy Spence Ezzell, Chaves County FRW, was recognized for having the most volunteer hours and Carolyn Atkinson received our state's Americanism Award. The NMFRW was recognized for their clubs' participation in the Mamie Eisenhower Literacy Program. However, the big surprise was the NMFRW receiving the NFRW Literacy and Education Award of which only one was given nationwide.

I had the wonderful privilege of visiting 16 out of 18 clubs. Everyone is so gracious, generous, and have wonderful clubs. I have no doubt that every club will continue their rein of success.

I was able to attend all National Board meetings both in person and on-line. This also includes the NFRW Biennial where our NFRW Regional Director Martha Jenkins was

Plus, I was able to visit with a few clubs, in the form of monthly general meetings, lunches and meet ups, as I traveled up and down the I-25 corridor.

I continued meeting with club members and officers as I traveled around Southern, Central, and Northern NM (again, it's that I-25 corridor thing). We bested Mississippi 83% to their 78%. It truly was a victory for all the club presidents who are on the front lines of growing membership, but I had a SO MUCH fun cheering on the "troops", and doing what I could, as an individual member, to bring in new members. I'll never forget all the calls from Rio Rancho President, Anita Leivo, who seemed to add at least one member a day during crunch time. And a special shout out to NMFRW Treasurer, Heather Curtis, who meticulously added each member up until the very end.

The clubs who reached the 70K membership goal set by NFRW include: Albuquerque (58), Dona Ana County (104), Enchanted North (25), Lea County (32), Lincoln County (57), Otero County (18), Rio Rancho, (39), San-Bern (57), Socorro County (22), Taos County (28), and Zia (43).

Many of the clubs who didn't quite reach the goal fell short of their goal by only a few members. Next year, ladies!!! The remaining club numbers are Chaves County (148), Four Corners (162), Los Alamos (33), Metro (10), Rio Grande (37), Santa Fe (89).

Another wonderful accomplishment for 2025 was adding the FRW Sierra County to our ranks. Special thanks for Jacqueline Bentley who, lucky for me, put up with all my bossiness as she and I worked through all the steps to charter a new club. Y'all, she is killing it!! They finished up the calendar year with 22 members and 16 associates. Special thanks to Teresa Barncastle, NMFRW President, and Nancy Brenna, NMFRW Secretary, who stepped in to keep the ball rolling when I was unavailable. It's a team effort, ladies!!

My tenure as 2nd VP would not have accomplished what is has or, more importantly, been as fun without all you ladies who journeyed with me. For that, I thank you all!!!

### Third Vice-President

Let me start by thanking you for allowing me this opportunity to be your 3rd Vice President for fundraising. It was no small effort.

In January of 2024 I asked ladies from around the state to serve with me: Joan Boue, Heather Curtis, and Anise Golden Morper. They agreed to serve on the committee with me and Teresa. Later I added Cyndi Runyon because I needed a true Region B member. We started having Zoom meetings in February of 2024.

We decided on two major goals. In 2024 we were to have a Gala and in 2025 we agreed to have a more modest effort such as a raffle. I pitched this idea to the Board of Directors at the February meeting in Santa Fe in 2024. The plan was approved.

In April we signed a contract with the Santa Ana Casino and Resort to host our big Gala on June 28, 2024. It was the only date where we could have our state meeting during the day and the Gala in the evening for one price. We signed Stephen Moore, one of Trumps executive advisors. The event was spectacular as a party with a fun silent auction, a comedian as an opening act, scrumptious steak and then Steve Moore. Everyone had a grand

time and walked away saying that the state put on a great event. Mission accomplished.

In the fall of 2024 Joan and Teresa both contacted a colleague of theirs in Roswell that makes beautiful quilts. She agreed to donate a large quilt to us if we just paid her for the cost of materials. We agreed. Teresa and I carefully read and re-read the statute that defines who can conduct a fundraiser and the rules to do it. We were off and running.

In early 2025 we displayed the beautiful prizes at the February board meeting and the June board meeting in Farmington. Raffle prizes include the quilt, valued at \$2500; a ladies Citizen Watch valued at \$300 donated by President Barncastle; and \$150 worth of President Trump Inaugural swag donated by President Barncastle and me.

We sent out flyers for every one to use in the promotion of the quilt raffle. We encouraged each club to sell at least 25 tickets and some clubs asked for 100 tickets. Tickets were sold for \$10 each or 3 for \$25. And most of the participants bought multiple tickets for \$25 or \$50.

Taos won the prize for selling the most tickets based on its membership by September 1. Taos sold 205% of its membership (21 members sold 43 tickets). Otero was next followed by Los Alamos. The winning tickets for our 3 prizes will be drawn Saturday night at our convention in Alburquerque.

Teresa gave a training on Achievement Awards concentrating on Calls and Hours.

Cristen Wohlgemuth from Mountain States Legal Foundation wrapped up the evening speaking about the foundation and what they do. She explained the purpose of government and

the appropriate use of each branch, the court system structure and the jobs of each level. Cristen explained how executive orders lacked the stability and durability needed for business planning. She spoke of the timing needed for planning in different types of businesses and explained how important legal stability is for economic planning and development.

The pre-convention concluded with an entertaining NM themed Trivia Game.

The NMFRW 2025 Biennial Convention began Saturday morning with clubs decorating tables with their chosen colors of New Mexico.

Cristen Wohlgemuth from Mountain States Legal Foundation continued speaking about executive orders and how Trump was working to restore Constitutional Order. She spoke of the 211 Executive orders that had been written by Trump to date and how they have generated 326 lawsuits that were filed against those executive orders. Cristine led discussions on some of those executive orders and the lawsuits they generated, stating "the minute we stop is the minute we lose." Mountain States Legal Foundation's job is to sue the government.

We broke into five groups to discuss and share information in our Mentorship Breakout sessions before Paul

Guessing from the Rio Grande Foundation spoke about the three topics his think tank focuses on. Our final speaker of the day was Martha Jenkins the NMFRW 1st Vice President and President Elect. Martha gave us a path forward, asked if anyone

# Committee Reports

### Campaign/Political Education

We are seeing changes in elections due to the election laws which took effect July 1, 2025.

Automatic Voter Registration (AVR) ensures that effective July 1, 2025, Motor Vehicle Division (MVD) customers who are also qualified electors will be automatically registered to vote pursuant to state law.

Before June 30, 2025, (MVD) customers had the opportunity to register to vote and designate their political party affiliation.

After July 1, 2025, if you are not registered to vote and are eligible based on New Mexico state laws, you will be automatically registered to vote through MVD and will receive a notice from your county clerk providing you with information on what to do next.

It will have all the information you need to know about being a registered voter, including, but not limited to, requesting a mailed ballot for an election and how to choose a political party ballot for an upcoming Primary Election.

It will also provide you with information on how to decline to be registered to vote. If the notice is not returned to the county clerk, you will remain a registered voter.

You can make changes to your voter registration information by visiting your county clerk's office.

Recent changes to New Mexico election law allows voters registered as "No Party Affiliation" (or Decline to State – DTS) to vote in primary elections. If you are registered with a minor party, you may not vote in a Primary Election unless you update your voter registration to reflect a major party or No Party Affiliation (DTS).

You can update your political party selection by returning the AVR notice with the selected party of your choice or by contacting your County Clerk's Office.

We are 2 weeks into the local elections and let me tell you they are much different than the general election last year. So far no crazy rush to register same day. I spoke with the Valencia County Clerk about the registration process with governmental agencies and some concerns I had. A question like....when individuals are asked to register do you get more than one registration for the same person and how do you handle it? The County Clerks have the task of determining if a person has more than one registration record and combining them if they do.

We have a new check-in system (Robis...Ask ED) in Valencia County. It is user friendly as it coaches the election clerk though the check-in process by giving them the questions to ask and the statements to make for each step. Through training challengers and participating in the Election Integrity Network of NM (EIN-NM) I have read through the Election Code and NM state statues and the information is consistent with them. This will make it easier for challengers and watchers as the process unfolds.

### Committee Reports (continued)

I was fortunate to attend two of the three trainings by the Leadership Institute for candidates, people who are working with candidates and leaders. I would recommend this training to anyone planning to run or run a campaign. I attended a training for Local School Board candidates put on by a state parliamentarian, and a training for 2025 School Board Candidate Campaign reporting put on by the SOS. All amazing trainings and recommended for candidates in these positions

We shared information we obtained such as how to dress, what your signs should look like, and how to get your name out to the public with our candidates and some are taking this to heart and running with it. We are starting to hear their names being whispered for the 2026 election.

This election, however, we have some mudslinging going on and in one community there is a big divide. I have spoken to many people on both sides, and my advice is the same. This is a good time for a meet and greet. The candidate has an opportunity to answer questions to support his/her stance, and the voter has the opportunity to ask questions to address their concerns. Visibility, a clean background and a good platform is essential. Don't forget we don't endorse or support one Republican Candidate over another. These meet and greets should be held by interested constituents not the FRW or the FRW officers unless you are doing the same for everyone.

You will find an Electronic Petitions Portal for the 2026 Election and new contribution levels for candidates. Don't forget the open primaries do not affect the upcoming Regular Local Election in November. The next Primary election will be in June 2026





- Zia celebrated its 85th Anniversary. We received a Proclamation from the City of Albuquerque and a proclamation from the NMFRW.


Zia made 100 percent of its membership goal for the 70K contest.


We will once again be a small but mighty force as we work with fellow Republicans to turn this state red!
